



Conceding or partially conceding is a good way to negotiate your point of view into being accepted whereas totally disagreeing, or raising your voice is likely to induce hostility and end up with yourbeing overturned.

My two pet peeves are being stuck in mismanaged meetings and in traffic jams. Traffic jams are often unavoidable but ineffective meetings are particularly irksome since it is simple to plan and manage successful meetings. Using the tools for creating dynamic and inspirational meetings doesn't require a Ph.D. or months of training. Why then are these simple ideas and tools so often ignored?

Meetings are too often seen as an end unto themselves. We've attended more than our share of meetings where the object was to get to the meeting. Once there, we dutifully filled the time allotted while producing only a minimum of new ideas, plans and action.

Using meetings effectively starts with the understanding that **meetings are not the destination but a vehicle** for reaching strategic objectives or organizational destinations. With this in mind we can move meetings forward.

Thinking of meetings as vehicles, as the means to an end, clarifies objectives and itineraries. It enables us to get in the drivers seat and focus our attention on the results we want to achieve and the means of achieving them. This requires selecting the appropriate type and structure of meeting, picking a competent meeting leader and

facilitator, determining the key participants, and identifying critical steps in order to make the best use of peoples' time and energy. The success of meetings is limited only by our understanding of their purpose and our ability to plan and manage them.

Good meetings help generate enthusiasm for a project, build skills for future projects, and provide participants with techniques that may benefit them in their future careers. As a chairperson, a secretary, or a group member, it is crucial to your meeting's success to know what your role is during a meeting. Since there are more than 11 million meetings held every day in the United States, there is a good chance that your life is full of meetings. There is a general agreement among business professionals that most meetings are not well run. They often waste your time, drain your energy, seem to have no purpose, and bear few positive results. Are you tired of attending meetings like this? Are you tired of your meetings ending up like this? This course will teach you how to make your meetings more successful by providing the tools and information that are necessary to lead an effective meeting.

With proper preparation and careful organization, a meeting can run smoothly. The most typical complaint about meetings is that they run too long. Meetings that run longer than necessary can be very costly to a company or business. As the famous business expression says: *Time is money*. Setting goals and time limits, keeping to the agenda, and knowing how to refocus, are key components of an effective meeting. This may sound simple in your own native language, but it is a little trickier when you or the participants do not speak fluent English. This unit will help you hold or attend a meeting with success.

# 1. Calling a Meeting

There are a number of ways that you may call or be called to a meeting. Some meetings are announced by e-mail, and others are posted on bulletin boards. If a meeting is announced at the end of another meeting, it is important to issue a reminder. A reminder can also come in the form of an e-mail or notice. Verbal announcements or reminders should always be backed up by documented ones. The date, location, time, length, and purpose of the meeting should be included. It is also important to indicate exactly who is expected to attend, and who is not. If you are planning on allocating someone to take on a certain role, make personal contact with that person to inform them of his or her duty.

### 1.3 Writing an agenda

In order to keep the meeting on task and within the set amount of time, it is important to have an agenda. The agenda should indicate the order of items and an estimated amount of time for each item. If more than one person is going to speak during the meeting, the agenda should indicate whose turn it is to "have the floor". In some cases, it may be useful to forward the agenda to attendees before the meeting. People will be more likely to participate in a meeting, by asking questions or offering feedback, if they know what is going to be covered.

### Sample agenda:

- **1** Welcome, Introduction: Tum (5 minutes)
- 2 Minutes from previous meeting: Jandara (10 minutes)
- 3 Japan Tours: Dhirawit (15 minutes)
- 4 N.A. Tours: Prasit (15 minutes)
- **5** Korean Tours: Prasarn (15 minutes)
- **6** Australian Tours: Pongpon (if time allows 10 minutes)
- 7 Feedback from last year: Everyone (15 minutes)
- **8** Vote on staff picnic: Everyone (15 minutes)
- **9** Questions/Closing remarks/Reminders: Everyone (5 minutes)

#### 1.4 Allocating roles

The person in charge of calling and holding a meeting may decide to allocate certain roles to other staff members. Someone may be called upon to take the minutes, someone may be asked to do roll call, and someone may be asked to speak on a certain subject. This should be done either in person, or in an e-mail.

### Task 3: Opening a meeting

#### 2.1 Small talk

Whether you are holding the meeting or attending the meeting it is polite to make small talk while you wait for the meeting to start. You should discuss things unrelated to the meeting, such as weather, family, or weekend plans.

### Sample dialogue: Practice in pairs

**Dhirawit**: Hi Thomas. How are you? **Thomas**: Great thanks, and you?

**Dhirawit**: Well, I'm good now that the warm weather has finally arrived. **Thomas**: I know what you mean. I thought winter was never going to end.

Dhirawit: Have you dusted off your golf clubs yet?

Thomas: Funny you should ask. I'm heading out with my brother-in-law for the first

round of the year on Saturday.

# 2.2 Welcome: Practice these sentences individually

Once everyone has arrived, the chairperson, or whoever is in charge of the meeting should formally welcome everyone to the meeting and thank the attendees for coming.

- Well, since everyone is here, we should get started.
- Hello, everyone. Thank you for coming today.
- I think we'll begin now. First I'd like to welcome you all.
- Thank you all for coming at such short notice.
- I really appreciate you all for attending today.
- We have a lot to cover today, so we really should begin.

### Sample welcome: Practice it individually

**Dhirawit:** I think we'll begin now. First I'd like to welcome you all -and thank everyone for coming especially at such short notice. I know you are all very busy and it's difficult to take time away from your daily tasks for meetings.

#### 2.3 Introductions: Practice these sentences individually

If anyone at the meeting is new to the group, or if there is a guest speaker, this is the time when introductions should be made. The person in charge of the meeting can introduce the new person, or ask the person to introduce him or herself.

- I'd like to take a moment to introduce our new tour coordinator.
- I know most of you, but there are a few unfamiliar faces.
- Saowapa, would you like to stand up and introduce yourself?
- Hi everyone. I'm Chalita. I'll be acting as Dr. Dhirawit's assistant while Naree is away on maternity leave.

### 2.4 Roll call/Apologies: Practice these sentences individually

If the meeting is a small group, it is probably unnecessary to take attendance out loud. The person who is taking the minutes will know everyone personally and can indicate who is present and who is absent. In a larger meeting, it may be necessary to send around an attendance sheet or call out names. If an important figure is absent, it may be necessary for the chairperson to apologize for his or her absence and offer a brief explanation for it.

- It looks like everyone is here today.
- If you notice anyone missing, please let Jane know so that she can make a note of it.
- Unfortunately, Komkrit cannot join us today. He has been called away on business
- Manop will be standing in to take the minutes today, as Wanwisa is home with the flu.

# 2.5 Objectives

Some people who hold meetings prefer to pass around copies of the agenda, and others will post a large copy on a wall, or use an overhead projector. No matter which format is used, attendees should be able to follow the agenda as the meeting progresses. Before beginning the first main item on the agenda, the speaker should provide a brief verbal outline the objectives.

# Sample introduction to the agenda: Practice it individually

**Dhirawit**: As you can all see here on the agenda we will be mainly talking about the upcoming tourist season. First we'll discuss the groups that will be coming in from Japan. After that we'll discuss the North American Tours, followed by the Korean tours. If time allows we will also discuss the Australian tours which are booked for early September. Next, I'm going to request some feedback from all of you concerning last year's tours and where you think we can improve. And finally, we'll be voting on where and when to have this year's staff picnic.

# Questions:

1. Is it polite to make small talk while you wait for the meeting to start?  And what should you discuss?
2. Who should formally welcome everyone to the meeting and thank the attendees for coming?
3. If anyone at the meeting is new to the group, who can introduce the new person, or ask the person to introduce him or herself?

# Task 4: Following the agenda

Instructions: Study the process of how to follow the agenda, and answer the questions that follow.

# 3.1 Taking the minutes

Anyone, including you, may be assigned to take the minutes at a meeting. Often someone who is not participating in the meeting will be called upon to be the minute-taker. Before a meeting the minute-taker should review the following:

- The minutes from previous meeting
- All of the names of the attendees (if possible)
- The items on the agenda

It also helps to create an outline before going to the meeting. An outline should include the following:

- A title for the meeting
- The location of the meeting
- A blank spot to write the time the meeting started and ended
- The name of the chairperson
- A list of attendees that can be checked off(or a blank list for attendees to sign)
- A blank spot for any attendees who arrive late or leave early

The minute-taker can use a pen and paper or a laptop computer and does not need to include every word that is spoken. It is necessary to include important points and any votes and results. Indicating who said what is also necessary, which is why the minute-taker should make sure to know the names of the attendees. If you cannot remember someone's name, take a brief note of their seating position and find out their name after the meeting. A minute-taker should type out the minutes immediately after the meeting so that nothing is forgotten.

# 3.2 Watching the time

One of the most difficult things about holding an effective meeting is staying within the time limits. A good agenda will outline how long each item should take. A good chairperson will do his or her best to stay within the limits. Here are some expressions that can be used to keep the meeting flowing at the appropriate pace.

- I think we've spent enough time on this topic.
- We're running short on time, so let's move on.
- We're running behind schedule, so we'll have to skip the next item.
- We only have fifteen minutes remaining and there's a lot left to cover.
- If we don't move on, we'll run right into lunch.
- We've spent too long on this issue, so we'll leave it for now.
- We'll have to come back to this at a later time.
- We could spend all day discussing this, but we have to get to the next item.

### 3.3 Regaining focus

It is easy to get off topic when you get a number of people in the same room. It is the chairperson's responsibility to keep the discussion focused. Here are some expressions to keep the meeting centered on the items as they appear on the agenda.

- Let's stick to the task at hand, shall we?
- I think we're steering off topic a bit with this.
- I'm afraid we've strayed from the matter at hand.
- You can discuss this among yourselves at another time.
- We've lost sight of the point here.
- This matter is not on today's agenda.

- Let's save this for another meeting.
- Getting back to item number 5...
- Now where were we? Oh yes, let's vote.

# 3.4 Voting

When issues cannot be resolved or decisions cannot be easily made, they are often put to a vote. Most votes occur during meetings. Votes can be *open*, where people raise their hands in favor or in opposition of the issue. In an open vote, the results are evident immediately. Other votes, such as who should be elected to take on a certain role, are private or *closed*. During private votes, attendees fill out ballots and place them in a box to be counted. The results may not be counted until after the meeting. Here are some specific expressions used during open voting:

- All in favor? (Those who agree raise their hands or say "Aye".)
- All opposed?
- Motion to hire more tour guides, moved by Thomas.
  (Suggestions or ideas that are put to a vote are called *motions*. When a person makes a suggestion, the term to use both during the meeting and in the minutes is *moved*.)
- Motion to hire more tour guides seconded by Nolan.
   (When another person agrees with the motion, it is seconded.)

When a motion is voted and agreed upon it is *carried*. When it is voted and disagreed upon it is *failed*. Most often votes are put to a majority. If there is a tie vote, the chairperson will often cast the deciding vote.

#### Sample voting session:

**Prasit**: Okay, now that we've covered most of the business, it's time to vote on the staff picnic. Jane and I have come up with two different ideas. I'll give Jane the floor now, and she'll outline these two options. After that we'll vote. I don't think there is any reason to have a private vote, so I'll just ask to see a show of hands. Jane, would you do the honors?

Jane: Thanks Prasit. Okay, so, as you all probably assumed, we are going to wait until most of the tours have passed through before we have the staff picnic. That way most of you should be able to attend. So we've chosen the last Sunday of September. I hope that works out for all of you. Now, the first option is to have a BBQ at Samila Beach, Songkhla. We would do this on the last Sunday of September. The second option is to have a potluck dinner/pool party in Prasit's backyard. The only problem with this is if it rains, there isn't much in the way of shelter there. I don't think Prasit and his wife will want all of us dashing inside in a thunderstorm.

Prasit: Well, if we had to we could probably squeeze everyone in the basement.

Anyhow, those are the options, so let's put it to a vote. All in favor of option number one? Raise your hands please...okay, one vote. And, all in favor of option number two? That's four. Okay, so it looks like a pool party at my house.

Jane: Great. I'll put up a sign up sheet and everyone can write down what they plan to bring.

# 3.5 Comments and feedback: Practice each of them individually.

During the meeting, participants will comment, provide feedback, or ask questions. Here are some ways to do so politely:

•	If I could just come in here
•	I'm afraid I'd have to disagree about that.
•	Could I just say one thing?
•	I'm really glad you brought that up.
•	I couldn't agree with you more. (I agree)
•	Jandara, could you please speak up. We can't hear you at the back.
•	If I could have the floor (chance to speak) for a moment
•	We don't seem to be getting anywhere with this.
•	Perhaps we should come back to this at another time?

# 4.1 Wrapping up: Practice these sentences individually.

There are different reasons why a meeting comes to an end. Time may run out, or all of the items in the agenda may be checked off. Some meetings will end earlier than expected and others will run late. The odd time, a meeting may be cut short due to an unexpected problem or circumstance. Here are a variety of ways to adjourn a meeting:

- It looks like we've run out of time, so I guess we'll finish here.
- I think we've covered everything on the list.
- I guess that will be all for today.
- Well, look at that...we've finished ahead of schedule for once.
- If no one has anything else to add, then I think we'll wrap this up.
- I'm afraid we're going to have to cut this meeting short. I've just been informed of a problem that needs my immediate attention.

# 4.2 Reminders: Practice these sentences individually.

There is almost always one last thing to say, even after the closing remarks. A chairperson might close the meeting and then make a last-minute reminder. Instructions for tidying up the room may also be mentioned.

- Oh, before you leave, please make sure to sign the attendance sheet.
- I almost forgot to mention that we're planning a staff banquet next month.
- Don't forget to put your ballot in the box on your way out.
- If I didn't already say this, please remember to introduce yourself to the new trainees.

- Could I have your attention again? I neglected to mention that anyone
  who wants to take home some of this leftover food is welcome to.
- If you could all return your chair to Room 7 that would be appreciated.
- Please take all of your papers with you and throw out any garbage on your way out.

# 4.3 Thank you and congratulations: Practice these sentences individually.

The end of the meeting is also the time to thank anyone who has not been thanked at the beginning of the meeting, or anyone who deserves a second thank you. Congratulations or Good luck can also be offered here to someone who has experienced something new, such as receiving a promotion, getting married, or having a baby.

- Before I let you go let's all give a big thank you (everyone claps) to Thomas for baking these delicious cookies.
- Again, I want to thank you all for taking time out of your busy schedules to be here today.
- Most of you probably already know this, but Manop's wife just gave birth to a baby boy.
- As you leave today, don't forget to wish Sopha luck on the weekend. The next time you see her she will be happily married.

# 4.4 Follow up: Practice these sentences individually.

In the closing remarks, the chairperson, or participants may want to discuss the date and time for the next meeting, when the minutes will be available, or when a decision should be made by. This is also the time to give contact information, such as how to send a question by e-mail or who to call regarding a certain issue.

- We'll meet again on the first of next month.
- Next time we meet I'll be sure to have those contacts for you.
- If anyone has any questions about anything we discussed today, feel free to send me an e-mail.
- The minutes from today's meeting will be posted as of tomorrow afternoon.

#### Introduction

The following dialogue is an example of a typical business meeting. As you can see from the dialogue, a typical business meeting can be divided into five parts:

This example business meeting is followed by the two sections which provide key language and phrases appropriate for typical business meetings.

#### Introductions

**Meeting Chairman:** If we are all here, let's get started. First of all, I'd like you to please join me in welcoming Jack Peterson, our Southwest Area Sales Vice President.

Jack Peterson: Thank you for having me, I'm looking forward to today's meeting.

**Meeting Chairman:** I'd also like to introduce Margaret Simmons who recently joined our team.

Margaret Simmons: May I also introduce my assistant, Bob Hamp.

**Meeting Chairman:** Welcome Bob. I'm afraid our national sales director, Anne Trusting, can't be with us today. She is in Kobe at the moment, developing our Far East sales force.

# Reviewing Past Business

**Meeting Chairman:** Let's get started. We're here today to discuss ways of improving sales in rural market areas. First, let's go over the report from the last meeting which was held on June 24th. Right, Tom, over to you.

**Tom Robbins:** Thank you Mark. Let me just summarize the main points of the last meeting. We began the meeting by approving the changes in our sales reporting system discussed on May 30th. After briefly revising the changes that will take place, we moved on to a brainstorming session concerning after sales customer support improvements. You'll find a copy of the main ideas developed and discussed in these sessions in the photocopies in front of you. The meeting was declared closed at 11.30.

## Beginning the Meeting

**Meeting Chairman:** Thank you Tom. So, if there is nothing else we need to discuss, let's move on to today's agenda. Have you all received a copy of today's agenda? If you don't mind, I'd like to skip item 1 and move on to item 2: Sales improvement in rural market areas. Jack has kindly agreed to give us a report on this matter. Jack?

# Discussing Items

**Jack Peterson:** Before I begin the report, I'd like to get some ideas from you all. How do you feel about rural sales in your sales districts? I suggest we go round the table first to get all of your input.

**John Ruting:** In my opinion, we have been focusing too much on urban customers and their needs. The way I see things, we need to return to our rural base by developing an advertising campaign to focus on their particular needs.

**Alice Linnes:** I'm afraid I can't agree with you. I think rural customers want to feel as important as our customers living in cities. I suggest we give our rural sales teams more help with advanced customer information reporting.

Donald Peters: Excuse me, I didn't catch that. Could you repeat that, please?

**Alice Linnes:** I just stated that we need to give our rural sales teams better customer information reporting.

John Ruting: I don't quite follow you. What exactly do you mean?

**Alice Linnes:** Well, we provide our city sales staff with database information on all of our larger clients. We should be providing the same sort of knowledge on our rural customers to our sales staff there.

Jack Peterson: Would you like to add anything, Jennifer?

**Jennifer Miles:** I must admit I never thought about rural sales that way before. I have to agree with Alice.

**Jack Peterson:** Well, let me begin with this Power Point presentation (Jack presents his report).

**Jack Peterson:** As you can see, we are developing new methods to reach out to our rural customers.

**John Ruting:** I suggest we break up into groups and discuss the ideas we've seen presented.

# Finishing the Meeting

**Meeting Chairman:** Unfortunately, we're running short of time. We'll have to leave that to another time.

Jack Peterson: Before we close, let me just summarize the main points:

- 1. Rural customers need special help to feel more valued.
- 2. Our sales teams need more accurate information on our customers.
- 3. A survey will be completed to collect data on spending habits in these areas.
- 4. The results of this survey will be delivered to our sales teams
- 5. We are considering specific data mining procedures to help deepen our understanding.

**Meeting Chairman:** Thank you very much Jack. Right, it looks as though we've covered the main items Is there any other business?

**Donald Peters:** Can we fix the next meeting, please?

**Meeting Chairman:** Good idea Donald. How does Friday in two weeks time sound to everyone? Let's meet at the same time, 9 o'clock. Is that OK for everyone? Excellent. I'd like to thank Jack for coming to our meeting today. The meeting is closed.



Assemble visual aids such as charts, handouts or slides.

Set definite starting and stopping times.		
Prepare an agenda. Explain the goal of the meeting; if there are many goals, decide which ones command priority, and make this clear.		
Circulate the agenda in advance to allow attendees to prepare.

# How to conduct successful business meetings? By Lars G. Harrison


Every day and week we attend meetings for staff related issues, planning, root cause, production, management review, and for many other business reasons. Some people spend more time in meetings than in performing their regular duties and responsibilities. Which in turn causes many to work overtime (without pay) to catch up on business communications, organize the in-basket, answering and placing routine memos and calls, and producing reports of their activities. An every business person spends a majority of time handling process or support related activities, instead of creating new opportunities for the company. This article will deal with some reasons for having meetings and how get the most out of meetings.

# a) When are meetings necessary and when could information be communicate differently?

There are times when meetings are not necessary. If there is a purpose for a meeting, then a meeting should be scheduled. However, before scheduling a meeting, you may want to ask yourself whether this information is better communicated with a memorandum, report, e-mail, video-conference, or taped message instead of arranging for a meeting. Is having a meeting the best way to communicate the information to the intended parties. If so, arrange for the meeting, and ensure that it is structured as a dialogue for optimum team learning.

# b) How to structure a dialogue for team learning.

The premise for most meetings should be the furtherance of team learning. Some meetings are not structured for a learning experience. If the purpose of the meeting is for team learning, it can best be experienced through a dialogue. A dialogue is different mode of communication than a discussion or a talk, which often are one-way communication or win-lose proposition. In a dialogue, because of its synergistic approach participants share a common meaning. This win-win relationship is often called group-think, but it goes beyond this concept. Dialogue means "through common meaning." In dialogue, people then become aware of their own thinking, its collective effect on the whole, which is capable of constant development and change. And the thought emanating from this activity becomes coherent. Bohm identifies three basic conditions that are necessary for dialogue:



These conditions allows a free flow of meaning to circulate the entire group, by the diminishing of resistance to the flow.

Participants *suspend their assumptions* by being aware of their assumptions and holding them up for examinations. Opinions could be subjective, but they cannot be defended or suppressed. The team must be disciplined to allow this free flow of shared meaning. Stereotypes and negative mental models should be abandoned. Participants will listen without forming opinions. Analyze the thought process and the results. Each participant must ensure open-mindedness, without bias or preconceived ideas.

Dialogue can only occur when a group of people see each other as colleagues in the mutual quest for deeper insight and clarity of the inquiry. Seeing each other as colleagues and friends makes for a positive, nourishing environment. Every one in the dialogue is equal, and there are no adversarial relationships allowed. People should leave their position at the door, and no hierarchy can be present in the meeting, except, of course for the facilitator. Fear and judgment must be replaced with love, understanding, and appreciation for difference. No opinion is stupid, but should be evaluate in the context of dialogue. Spirit of inquiry would allow participants to explore the thinking behind their views. Views must be substantiated by fact or opinion put on the board for further evaluation.

The *facilitator* should be a good process facilitator capable of helping people maintain the ownership of the process and the outcome. This person is responsible for guiding and influencing the flow of development by looking at all sides of the observation made by a participant.

c) Guidelines we have found that contribute to effective meetings.

Here are a few guidelines that we have found makes meetings effective. -

Clearly Communicated and Distributed Agenda - Purpose of the meeting. Once you have determined that a physical meeting is necessary either at a location or via teleconference, you must determine what the purpose of the meeting is, who should attend and put together the agenda, with or without the input from the participants. A meeting location should be confirmed and booked, refreshments and food ordered, participants contacted well ahead of schedule, presenter given enough time to prepare presentation. Solicit input for the structure of the meeting from presenters and others, if necessary. If there is a need for participants to teleconference, a bridge and time should be booked. This agenda should be sent well ahead of schedule (possibly in form of a memorandum) to all participants. A day before the meeting, send a reminder. Bring extra copies of the meeting agenda to the meeting. The agenda should detail:

•	Date and starting time and ending time
•	Meeting location (map included, if necessary)
•	List of participants and presenters.
•	Subjects covered so participants can review and bring material to the meeting for discussion.
•	Time limit for presentations or topics so speakers are motivated to present their specific points.

**Ensure that the meeting is a dialogue and not a discussion (if it is not merely a presentation).** Meetings should not be confused with presentations, management update, forums, and other one-way communication activities. To get the most out of meetings, ensure that the meetings are held in a dialogue mode, with other guidelines added for success. If participants of the meeting are not educated in the dialogue

**Assign a Scribe.** As the meeting coordinator or owner of the meeting and its process, it is necessary that you assign a impartial person to act as a scribe (note taker). Inform this person of what types of notes that you expect him/her to take. Provide this person with a laptop computer or the least an agenda with space for notes.

**Assign a Facilitator /Timekeeper.** The Facilitator/timekeeper's duties are to control the meeting to ensure that it follows the agenda, guide the dialogue (process), distill fact findings, and control and maintain the Q&A session, and to provide input to ensure that the meeting is successful. A regular sports-time watch can be used to time speakers and the round robin session.

**Round Robin Q&A session.** A Round Robin Q&A session often follows after a presentation has been made. Each participants is allotted two minutes to speak his/her mind and address questions, concerns or inputs to the presenter. In the first round every participant must speak. In the second and third rounds, participants may defer from

offering their input or yield the time to another participant. It is the facilitator's role to guide this process, to ensure that Q&A session is in line with the topic at hand.

**Team communications.** To continue the dialogue and the success of the team learning, certain communications and protocols should be maintained to continue the free flow of shared meaning, and to resolve issues that came up. The issues put on the parking lot that cannot be resolved at the meeting, should be assigned to a particular owner with a timeline for successful completion and delivery to the team. An action register for these particular issues should be discussed and completed by the team.

# Last thought on making meetings effective

The dialogue approach to team learning has proved very effective in my experience. It is recommended that you follow this approach in structuring your meetings. The culture, education level, type of activity and many other factors will determine the final structure of your various meetings. Naturally some meetings will take a different form than others. You may add to this structure any aspects that can greatly influence the outcome and accomplishment of your meetings. If you follow these guidelines, your meetings will become more effective.

# T) HISTORY

Video conferencing uses telecommunications of audio and video to bring people at different sites together for a meeting. This can be as simple as a conversation between two people in private offices (point-to-point) or involve several sites (multi-point) with more than one person in large rooms at different sites. Besides the audio and visual transmission of people, video conferencing can be used to share documents, computerdisplayed information, and whiteboards.

Simple analog videoconferences could be established as early as the invention of the television. Such videoconferencing systems consisted of two closed-circuit television systems connected via cable. During the first manned space flights, NASA used two radiofrequency (UHF or VHF) links, one in each direction. TV channels routinely use this kind of videoconferencing when reporting from distant locations, for instance. Then mobile links to satellites using special trucks became rather common.




ਨ੍ਹ Videoconferencing first demonstrated in 1968

This technique was very expensive, though, and could not be used for more mundane applications, such as telemedicine, distance education, business meetings, and so on, particularly in long-distance applications. Attempts at using normal telephony networks to transmit slow-scan video, such as the first systems developed by AT&T, failed mostly due to the poor picture quality and the lack of efficient video compression techniques. The greater 1 MHz bandwidth and 6 Mbit/s bit rate of Picturephone in the 1970s also did not cause the service to prosper.

It was only in the 1980s that digital telephony transmission networks became possible, such as ISDN, assuring a minimum bit rate (usually 128 kilobits/s) for compressed video and audio transmission. The first dedicated systems, such as those manufactured by pioneering VTC firms, like PictureTel, started to appear in the market as ISDN networks were expanding throughout the world. Video teleconference systems throughout the 1990's rapidly evolved from highly expensive proprietary equipment, software and network requirements to standards based technology that is readily available to the general public at a reasonable cost. Finally, in the 1990s, IP (Internet Protocol) based videoconferencing became possible, and more efficient video compression technologies developed, permitting desktop, or personal computer (PC)-based videoconferencing. In 1992 CU-SeeMe was developed at Cornell by Tim Dorcey et al., IVS was designed at INRIA, VTC arrived to the masses and free services, web plugins and software, such as NetMeeting, MSN Messenger, Yahoo Messenger, SightSpeed, Skype and others brought cheap, albeit low-quality, VTC.

# 2) Technology



A modern dual plasma video conferencing system. The Plasma on the left is primarily used to show people during the conference or the user interface when setting up the call. The plasma on the right is used to show data in this case but can be used for displaying a 2nd 'far site' in a multipoint call.

The core technology used in a videoteleconference (VTC) system is digital compression of audio and video streams in real time. The hardware or software that performs compression is called a codec (coder/decoder). Compression rates of up to 1:500 can be achieved. The resulting digital stream of 1's and 0's is subdivided into labelled packets, which are then transmitted through a digital network of some kind (usually ISDN or IP). The use of audio modems in the transmission line allow for the use of POTS, or the Plain Old Telephone System, in some low-speed applications, such as videotelephony, because they convert the digital pulses to/from analog waves in the audio spectrum range.

# 3) Multipoint videoconferencing

Simultaneous videoconferencing among three or more remote points is possible by means of a Multipoint Control Unit (MCU). This is a bridge that interconnects calls from several sources (in a similar way to the audio conference call). All parties call the MCU unit, or the MCU unit can also call the parties which are going to participate, in sequence. There are MCU bridges for IP and ISDN-based videoconferencing. There are MCUs which are pure software, and others which are a combination of hardware and software. An MCU is characterized according to the number of simultaneous calls it can handle, its ability to conduct transposing of data rates and protocols, and features such as Continuous Presence, in which multiple parties can be seen onscreen at once.

MCUs can be stand-alone hardware devices, or they can be embedded into dedicated VTC units.

Some systems are capable of multipoint conferencing with no MCU, stand-alone, embedded or otherwise. These use a standards-based H.323 technique known as "decentralized multipoint", where each station in a multipoint call exchanges video and audio directly with the other stations with no central "manager" or other bottleneck. The advantages of this technique are that the video and audio will generally be of higher quality because they don't have to be relayed through a central point. Also, users can make ad-hoc multipoint calls without any concern for the availability or control of an MCU. This added convenience and quality comes at the expense of some increased network bandwidth, because every station must transmit to every other station directly.

High speed Internet connectivity has become more widely at a reasonable cost and the cost of video capture and display technology has decreased. Consequently personal video teleconference systems based on a webcam, personal computer system, software compression and broadband Internet have become affordable for the general public. Videoconferencing is a very useful technology for telemedicine and telenursing applications, such as diagnosis, consulting, transmission of medical images, etc., in real time. Using VTC, patients may contact nurses and physicians in emergency or routine situations, physicians and other paramedical professionals can discuss cases across large distances. Videoconferencing can enable individuals in faraway places to have meetings on short notice. Time and money that used to be spent in traveling can be used to have short meetings. Technology such as VOIP can be used in conjunction with desktop videoconferencing to enable face-to-face business meetings without leaving the desktop, especially for businesses with wide-spread offices. The technology is also used for telecommuting, in which employees work from home.

Telepresence videoconferencing, where participants are able to see each other in reasonable life-like sizes and little delay in video transmissions, has started to make an impact on business meetings. Some good business cases have been built on substitution of international travel with telepresence conferencing.

Videoconferencing is now being introduced to online networking websites, in order to help businesses form profitable relationships quickly and efficiently without leaving their place of work.

# Types of brainstorming

# a) Group brainstorming



To brainstorm usually means to solve problems by having a group of people discuss them and spontaneously suggest ideas or solutions. A brainstorming session is meant to be very open and non-critical. A "bad" or "silly" idea may lead to an idea that is very helpful, so suggestions are left un-judged at first. It is best to set a rough deadline for this free-for-all part of the session, after which the ideas and solutions are evaluated for whatever usefulness they may have.

Again, it is very important that the ideas are not criticized when first presented. To brainstorm effectively, you can't stifle the creative process. If your group has a difficult time with this aspect of the exercise, you could try having them write their ideas down and submit them anonymously. When nobody knows who suggested which ideas, everyone will feel freer to say what they want.

Unfortunately, you will lose much of the value of the session doing this, because individuals will not be spontaneously feeding off of each others ideas. It may be better than nothing, but try to create that non-critical environment and brainstorm in the open for the best result.

# b) Solo brainstorming



To brainstorm by yourself, start by writing down the problem to be solved. Then write it down several more times, restating it each time. "We need to save money for a down payment on a house," may be restated as "We need to buy a house," and "We need to get out of this place." Now just spend thirty minutes writing down all the elements of the problem, and everything that comes to mind. Try several creative problem-solving techniques also, writing down the solutions and ideas that are produced. As with brainstorming in a group, it is important at this point that you don't stifle the creative process by judging your ideas.

When you are done with this part, you should have a mess. Only now should you look at that mess with a critical eye. Pick through for the ideas with the most potential. If you are lucky, the best solution may jump out at you. More often you'll have a few decent possibilities that you have to evaluate further. Brainstorm again if you have to.

# Task 4: Writing

Instructions: Read the following 12 brainstorm rules and summarize them in one paragraph.

#### 12 Brainstorm rules

**1. Number of members and constitution of group**: A minimum of 6 and a maximum of 12 people may participate in a brainstorming session. Less than 6 results in argument, more than 12 means that not everyone gets heard. It is recommended that people from different disciplines (specialists, generalists, the client, and outsiders unconnected to the problem) are included.

- **2. Duration:** The session should last at least 3 hours (or a minimum of 1 hour for smaller projects).
- **3. Use of time:** The facilitator must plan out the 3 hour session, blocking out periods of time to the various areas that have to be covered, and ensuring that the group sticks to the plan.
- **4. Pre-session requirement:** The facilitator must initiate brainstorming 1 to 2 days before the actual session by circulating a memo with:
  - Location, time and date of the session
  - The subject of the session
  - A definition of the end result or product that is wanted
  - Any deadlines for end product or idea
  - Names of the participants and any special tasks for participants named
  - Supporting background information
  - Explanation of rules for session
- **5. Seating arrangement:** the group should sit in a circular fashion (around a rectangular 'meetings room' desk is fine) so that everyone can see each other. The facilitator and scribe should sit at one side with the board or flip charts behind them.
- 6. Facilitator's requirements during session:
  - Be able to stand in front of group and communicate objective clearly and interestingly
  - Keep the group's energy high and raise it if it fades
  - Control dominating participants and encourage shy members to join in too
  - Keep group on track and focused on productive objectives
  - Put aside personal ideas and views in favor of the group's ideas and input
  - Use different techniques to draw ideas from group
  - Keep meeting on schedule
  - Spot opportunities that come up and are not picked up or developed by group

- Make sure the scribe is capturing all ideas in writing
- Squash all side-conversations with "Just one meeting, please!"
- Act as policeman for the golden rule
- **7. The Golden Rule of Brainstorming: DEFER JUDGEMENT.** All ideas are made welcome. Participants must agree not to laugh at or belittle any idea raised during a brain storm session.
- **8. Quantity, not quality:** as an ancilliary point to the Golden Rule above, aim at quantity of ideas rather than quality. To this end, employ Caesar's military strategy he called *celeritas* speed! High tempo fast generation of ideas helps keep the internal judge at bay and ensures that the golden rule is obeyed.
- **9. Encourage active listening:** participants will bring greater attention and awareness to the task and will get more information if they commit to actively listening to those who are presenting ideas at any moment.
- **10. Keep on track:** the facilitator must beware of the group veering off into unproductive areas and steer it back to the task at hand. He must also guard against participants making judgments and watch out for "veiled warfare" amongst the more dominant members, steering them back in line with the golden rule.
- **11. Keep the group energized:** if the meeting gets mired and sleepy, take a few minutes to get everyone to stretch and move around. Get some refreshments to keep blood sugar levels stable. Blast out mental cobwebs with some creativity games, some energizing music, a funny video or some jokes. Then re-start the session.
- **12. Summarize agree allocate:** as the brainstorm session draws to a close, summarize what has been covered and where you are, obtain the participant's agreement on that and allocate tasks from the list of quality ideas that you have harvested from the session.

# Task 5: Solo brainstorming

Instructions: Study this scenario and then write down everything that comes to mind.



The scenario: your business is spending too much on delivery costs. You restate the problem twice, then write down everything that comes to mind. You try a problem-solving technique like the "assume the absurd". This leads you to the idea, "Let's not deliver," which seems crazy since most of your customers are in other states. Then it occurs to you that if you delivered all orders for a city to a central distribution point, instead of to individuals, it would be more efficient. The customer could drive a short distance to pick up their order, with the advantage that they could return the product immediately if they were dissatisfied (no need to pack and ship). You write this idea down and move on. Of course you also write down the obvious, such as "negotiate lower delivery rates," or "find another delivery company." When you are done brainstorming you pick through the ideas and decide on a couple to explore further, before choosing the best solution.

Task 6: Group brainstorming

Instructions: Study this scenario and do the group brainstorming.



**Origin:** During the late 1930's and early 1940's, advertising director Alex Osborn developed a technique for generating new product slogans and ad campaign ideas amongst his employees. He would meet with his group around a table, outline the problem and then have them generate ideas willy-nilly. Out of the scores of ideas generated, a few would turn out to be real gems. This idea-generating activity evolved and became known as "**brainstorming**" and it is still being used by top companies and creative individuals all around the world.

**Uses:** You can use it to generate super ideas for writing, business or any other activity that you are involved in, either through traditional group brainstorming sessions or through solo 'wildcatting' brain storm sessions. Brainstorming is a technique that allows you to generate a large quantity of ideas in a short period of time. It aims to bypass the logical 'censor' mind and access the more creative parts of your brain.

**Group brainstorming technique**: the session involves a group of 6 to 12 people who are briefed prior to the session on what they will be covering. (Participants are encouraged to generate their own written ideas prior to the session to bring to the meeting.) One of the participants will act as the facilitator to organize and control the session. Someone else will act as a scribe or secretary to takes detailed note of ideas generated. The group should be arranged in a non-threatening seating layout with all participants facing each other, with the scribe and facilitator at one side with flip charts behind them to write down the ideas that are generated. The facilitator steers the session where necessary to keep it focused on profitable topics. The facilitator also encourages everyone to participate, and ensures that no ideas are reacted to negatively. The whole point is to go for QUANTITY of ideas rather than QUALITY. If you focus on quantity, the quality will come.
